A complete set of Biddings Documents may be purchased by interested Bidders on May 25 - June 13, 2023 from the address below and upon payment of a non-refundable fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB in the amount of **TWENTY FIVE THOUSAND PESOS (P 25,000.00)** for Item 1, **TEN THOUSAND PESOS (P 10,000.00)** for Items 2, 3, 4, 5, 6 & 7 and **FIVE THOUSAND PESOS (P 5,000.00)** for Items 8, 9 & 10. The Procuring Entity shall allow the bidder to present its proof of payments for the fees in person.

The Procuring Entity will hold a Pre-Bid Conference on June 1, 2023, 10:00 o'clock A.M. at BAC Office, Kabankalan City Hall, Justice Jesus Y Perez Highway, Brgy. Talubangi, Kabankalan City, Negros Occidental.

Bids must be duly received by the BAC Secretariat through manual submission at the address as indicated below on or before 1:00 o'clock P.M. of June 13, 2023. Late Bid shall not be accepted. Bid received in excess of the ABC shall be automatically rejected at bid opening.

All bids must be accompanied by a Bid Security in any of the acceptable form and in the amount stated in ITB Clause 15.

Bid opening shall be on June 13, 2023 at 2:00 o'clock P.M. at the given address below. Bid will be opened in the presence of the bidders representative who choose to attend the activity.

The Local Government Unit of Kabankalan City, Negros Occidental reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 35.5 and 41 of the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184, without thereby incurring any liability to the affected bidder or bidders.
