CONTRACT AGREEMENT

Contract No. Goods-23-138

THIS AGREEMENT made this ____ day of _____, between City of Kabankalan, Negros Occidental, of the Philippines, hereinafter called “the Entity” of the one part, BACOLOD D’JADE MARKETING INC. of Bacolod City, Philippines, hereinafter called “the Supplier” of the one part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, *Feeds supplies for Animal Breeding & Genetic Improvement Center (ABGIC) use*, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SIX HUNDRED FIFTY ONE THOUSAND THREE HUNDRED TWENTY FIVE PESOS ONLY (PhP651,325.00)**, hereinafter called “the Contract Price”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS
