THIS AGREEMENT made this ____ day of _____, between City of Kabankalan, Negros Occidental, of the Philippines, hereinafter called “the Entity” of the one part, BEROVAN MARKETING, INC. of Bacolod City, Philippines, hereinafter called “the Supplier” of the one part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, *Four (4) units Hospital Bed for Kabankalan City Hospital Medical and Health Program for Marginalized Women*, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **EIGHTY THOUSAND FOUR HUNDRED PESOS ONLY (PhP80,400.00)**, hereinafter called “the Contract Price”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS
