THIS AGREEMENT made this ____ day of _____, between City of Kabankalan, Negros Occidental, of the Philippines, hereinafter called “the Entity” of the one part, SUNTECH TRADING & MARKETING of Kabankalan City, Philippines, hereinafter called “the Supplier” of the one part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, *Computer Sets and Printers for different Barangays of the City (P.R No. CMO-2023-366)*, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **NINE HUNDRED SEVENTY FIVE THOUSAND SIX HUNDRED PESOS ONLY (PhP975,600.00)**, hereinafter called “the Contract Price”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS
