# CONTRACT AGREEMENT

Contract No. Goods-23-146

THIS AGREEMENT made this \_\_\_\_ day of \_\_\_\_\_, between City of Kabankalan, Negros Occidental, of the Philippines, hereinafter called “the Entity” of the one part, EMIE GROCERY STORE of Kabankalan City, Philippines, hereinafter called “the Supplier” of the one part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, *Purchase of Food & Non Food items to be used during calamity*, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **NINE HUNDRED FIFTY ONE THOUSAND TWO HUNDRED PESOS ONLY (PhP951,200.00)**, hereinafter called “the Contract Price”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

- iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
