EXECUTIVE ORDER NO. 35-2023

RECONSTITUTING THE CITY PROJECT MONITORING COMMITTEE (CPMC) OF THE CITY OF KABANKALAN

WHEREAS, Republic Act No. 7160 or the Local Government Code of 1991, devolves the monitoring and evaluation (M&E) of programs and projects to local government units (LGUs);

WHEREAS, DILG Memorandum Circular No. 2019-188 enjoined concerned local government officials to organize Local Project Monitoring Committee (LRMC) in their respective areas of jurisdictions if not yet established, or reconstitute if already existing, and to inform LPMCs of their functions and responsibilities;

WHEREAS, DILG Memorandum Circular No. 2004-78 provides for the organization and reconstitution of PMCs nationwide and to further strengthen the roles of said committee in ensuring transparency and accountability in the implementation of local development programs and projects;

WHEREAS, Executive Order No. 376 series of 1989, as amended by Executive Order No. 93 Series of 1993, provides for the establishment of the Regional Monitoring and Evaluation System (RPMES) as an institutional mechanism for monitoring and evaluating projects at the national, regional, provincial, and city/ municipality levels;

NOW, THEREFORE, I, BENJIE M. MIRANDA, City Mayor, by virtue of the powers vested upon by law, do hereby reconstitute the City Project Monitoring Committee (CPMC) as follows:

Section II. ROLES AND RESPONSIBILITIES

The roles and responsibilities of the City Project Monitoring Committee (CPMC) and Secretariat are as follows:

CPMC functions:

- a. Provide the list and schedule of all projects to be monitored to NGOs involved in project monitoring;
- b. Collect and process report of implementers and NGO monitors on the status of project implementation for the information of the LDC and next higher-level PMC;
- c. Determine problems related to the information of programs and projects and verify information to be submitted for analysis and action of the LCDC;
- d. Provide feedback on the remedial actions of the LDC and follow up implementation;
- e. Prepare and disseminate periodic project monitoring report on the status of project implementation to the Regional PMC (RPMC); and
- f. Elevate to higher level bodies (e.g., National PMC (NPMC), RPMC) issues and problems which are not resolved at the LPMC level.


CPMC Secretariat functions:

- a. Prepare the M&E work program to be undertaken by the PMC during any given fiscal year which will include the list of the projects and schedule of implementation based on submission of implementing agencies;
- b. Provide the Local Chief Executive with information on projects to be monitored by the PMC; and
- c. Facilitate inter-agency, inter-governmental, and field headquarters coordination, if necessary.

Section III. EFFECTIVITY

This Executive Order shall take effect immediately.
